Marilyn motioned to adjourn Deb R seconded. Adjourned at 5:00PM

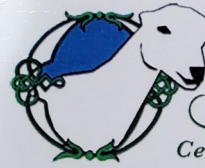

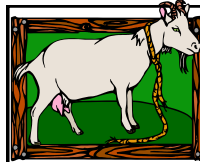
